Bi-State to Honor FMCSA Administrator Raymond P. Martinez



The Association of Bi-State Motor Carriers is proud to announce the recipient of its 2018 Malcom McLean Award: Federal Motor Carriers Safety Administration Administrator Raymond P. Martinez.

The Malcom McLean Award, named for the industry visionary who revolutionized worldwide commerce with containerized shipping, is the highest honor given out at the Bi-State’s annual Golf Outing & Awards Luncheon (*this event will be held on September 17, 2018; please see page 2 for full details*). The award is given to a recipient who exemplifies the traits of Malcom McLean: a strong leader who has made positive contributions to the advancement of the transportation industry.

“Administrator Martinez was chosen to receive this award in recognition of his strong leadership and forward-thinking ideals,” said Executive Director Dick Jones, “which have resulted in a high level of communication between the FMCSA and the motor carrier community, directing us towards a climate of greater understanding and cooperation, with safety as our common priority.”

As the Administrator for the FMCSA, Ray Martinez works to maximize safety on U.S. roadways, a task to which he has dedicated much of his career, having also served as the Chairman and Chief Administrator for the New Jersey Motor Vehicle Commission, the Commissioner of the New York State Department of Motor Vehicle, and Chairman of the NYS Highway Traffic Safety Committee. The McLean Award recognizes his long-standing commitment to safety and compliance, and the positive impact these efforts have had on our industry.

Past recipients of this award include New York Shipping Association President John Nardi (2017), and Federal Maritime Commission Chairman Mario Cordero (2016).

USDOT Interstate Pilot Program for Young Drivers

Earlier this month, U.S. Secretary of Transportation Elaine L. Chao announced that the Department of Transportation will launch a pilot program to permit 18-20 year olds who possess the U.S. Military equivalent of a commercial driver’s license (CDL) to operate large trucks in interstate commerce. “This program will allow our Veterans and Reservists to translate their extensive training into good-paying jobs, operating commercial vehicles safely across the country, while also addressing the nationwide driver shortage,” said Secretary Chao.

The pilot program will grant a limited number of individuals between the ages of 18 and 20 to operate large trucks in interstate commerce, provided they possess the Military equivalent of a CDL and are sponsored by a participating trucking company. Legislative Update: Meeting with Assemblywoman Quijano

Association President Jeff Bader met with District 20 representative Assemblywoman Annette Quijano at her legislative office in Elizabeth to go over topics of concern to the Bi-State membership. They discussed the Bi-State’s ongoing efforts to preserve the independent contractor model in New Jersey, the need to establish consistent gate hours port-wide, the impact of the truck replacement mandates and the need for increased funding for that program, and ways in which the Bi-State has been working to increase job growth in the region and encourage local workforce development in the fields of trucking, logistics and warehousing. The Assemblywoman’s continued support for the port community, as demonstrated by her dedication to keeping the lines of communication open with our organization and its members, is greatly appreciated.



Vehicle Cybersecurity Recommendations from the NHTSA

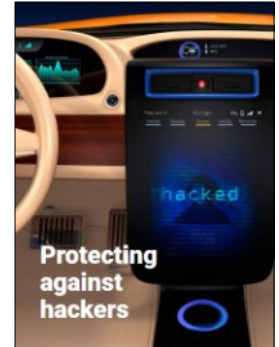
According to the National Highway Transportation Safety Administration, the advent of vehicle technology tools has led to a growing concern over the security of such devices.



“Advanced driver assistance technologies depend on an array of electronics, sensors, and computer systems,” the agency said. “In advancing these features and exploring the safety benefits of these
